WITNESS: The autopsy started around 8:30 PM ATTORNEY: And Mr. Denton was dead at the time? WITNESS: If not, he was by the time I finished.

#### Definition of "Unclaimed"

 Unclaimed bodies differ from unidentified bodies, as the morgue knows who the person is, but they have not been claimed by friends or family. So why are so many bodies unclaimed? According to the **National Funeral Directors Association**, the average cost of a funeral in 2021 was more than \$7,800. Often marginalized people do not claim their family members due to burden of cost. In fact, due to rising costs of funerals, in 1984 the Federal Trade Commission issued a Funeral Rule allowing consumers to request prices over the phone or in writing prior to making funeral arrangements. Additionally, over the years unclaimed dead bodies have been on the rise due to the opioid crisis, the COVID-19 pandemic, natural disasters, and homelessness. \*family dynamics


#### Statistics...

- 34,000 bodies
- Conservative estimates are that 1 percent of all deaths result in an unclaimed body, which would mean that last year, when 3.4 million Americans died, there were 34,000 bodies left for local governments to bury.

## What did society do before now?

- Donation (Iowa code when speaker was first in funeral serviceuse telegraph; funeral home donation/county funding; church/ societal claim of body.
- So where does the law stand with unclaimed dead bodies today? In most states, unclaimed dead bodies are still used for medical research. Human cadavers are needed for research and medical training, and with a shortage of bodies being donated, institutions rely on unclaimed bodies. In New York State, however, unclaimed bodies cannot be used as a cadaver without consent from the spouse, next of kin, or an organ donation registration. Within the city, the Department of Corrections pays their inmates to bury the unclaimed dead. Hart's Field on Hart's Island- over one-million interred. To give you a comparison, Arlington has 400,000 interred.

## Donations today...

- University of Iowa and Des Moines University:
  - 1. Des Moines University- will no longer accept due to liability.
    Probably number one reason schools are declining.
  - 2. What liabilities exist? Unknown status (Michael Jordan's father), religious (Muslim, Islamic), medical history of decedent, and publicity.
- 3. Publicity- Cut up and leased out, the bodies of the poor suffer a final indignity in Texas
- The University of North Texas Health Science Center built a flourishing business using hundreds of unclaimed corpses. It suspended the program after <u>NBC News</u> exposed failures to treat the dead and their families with respect.

## How to find state laws/options

- National Survey of State Laws
- HeinOnline has a few different resources for researching the law of unclaimed dead bodies across the United States. In fact, we have a dedicated resource for this exact topic! #### Veterans

- Indigent Veterans and Unclaimed Remains
- Reimbursement may be available for indigent Veterans and unclaimed remains. Indigent Veterans are those who do not enough resources available in their estate to cover the burial and funeral expenses when they pass away. Unclaimed remains occur when Veterans pass away and are not claimed by relatives, friends, and/or a legal representative.
- Iowa- benefit of the Iowa Veterans Cemetery, passing in a VA Hospital, IVH or under VA care in hospice/nursing home/ private home.

## Understanding unclaimed...

- My little history in funeral service is 37 years long- here are some of the issues related to unclaimed I have seen in those years.
- 1. AIDS epidemic. Many family members in charge as of the order of survivorship would not claim the body because of the cause of death. This left partners in limbo with the ability to give the decedent last wishes, but perhaps were not able to because family issues. Especially with cremation. Parents not signing cremation authorizations, etc. Some family members would not claim the urns. This is one huge reason the lowar form Declaration of Designee has been so successful. This was an episode of combined lack of education on the disease and struggles of the moral bounds. Lutheran General Chicago had two morgues in the late 1980s- one traditional death, one AIDS. 8 deaths per day.

#### Continued....

- 2. Cook County Morgue- 500 bodies in house at all times. End of the month, approximately 250 bodies taken to Indiana for burial. Copper wires with ID tags placed on inverted burials in case of identification. Who do you think is the number one party in Cook County to report unclaimed or unidentified human remains?
- 3. New Chicago area County- some bodies will be released to mortuary school that will handle embalming followed by cremation in-house. Prior all burial.

## Challenges now...

- The fact that entering into these types of deaths knowing that they will be exhausting, time-consuming and emotionally draining.
- 1. Hospital morgues and periodically medical examiner morgues. One thing hospitals don't like to invest in is a morgue cooler because they can't bill anyone for that service. The capacity of the hospital morgue is dwindling for many reasons:
  - A. Smaller towns limiting services and transferring to larger towns for medical care when death occurs.
  - B. Distance from performing funeral home.
  - C. Family cannot be contacted.
  - D. No commitment to the funeral home by the family for services and/or financial agreement. Once decedent is in care of the funeral home, very hard to discuss these details.

## Challenges...continued

- 2. Who is the legal next of kin- and finding them? Falsification of status. (Our people-search policy).
- 3. Information that can be accessed about insurance, finances, etc.
- 4. Responsible party steps forward but not the LEGAL responsible party.
- 5. Attorney telling family not to sign anything- funeral homes are required by Federal requirements and state requirements to have certain documents.
- 6. Due diligence- making sure we are reaching out to everyone in a group that should be- all children, etc. Social media (Facebook) does help with this and with small town lowa, calling the local funeral home there to see if they know them has worked.

#### What do we do to fix this?

142.1 Delivery of bodies. The body of every person dying in a public asylum, hospital, county care facility, penitentiary, or reformatory in this state, or found dead within the state, or which is to be buried at public expense in this state, except those buried under the provisions of chapter 144C or 249, and which is suitable for scientific purposes, shall be delivered to the medical college of the state university, or some osteopathic or chiropractic college or school located in this state, which has been approved under the law regulating the practice of osteopathic medicine or chiropractic; but no such body shall be delivered to any such college or school if the deceased person expressed a desire during the person's last illness that the person's body should be buried or cremated, nor if such is the desire of the person's relatives. Such bodies shall be equitably distributed among said colleges and schools according to their needs for teaching anatomy in accordance with such rules as may be adopted by the department of health and human services. The expense of transporting said bodies to such college or school shall be paid by the college or school receiving the same. If the deceased person has not expressed a desire during the person's last illness that the person's body should be buried or cremated and no person authorized to control the deceased person's remains under section 144C.5 requests the person's body for burial or cremation, and if a friend objects to the use of the deceased person's body for scientific purposes, said deceased person's body shall be forthwith delivered to such friend for burial or cremation at no expense to the state or county. Unless such friend provides for burial and burial expenses within five days, the body shall be used for scientific purposes under this chapter. ## Speaker's thoughts....

- 1. I never thought we would be having this discussion on the needs of unclaimed individuals. That is New York, California, etc. But now, it's also Marshalltown, Iowa. Late finds were the "bad" calls, but they are a breeze now- it's the unclaimed/family dynamic ones.
- 2. If you have a relationship with the funeral homes in your area, can you network with them? Here is our network with Dr. Bethel and Marshall County Board of Supervisors....
- 3. Understanding needs vs. wants in family dynamics.
- 4. Firm, black and white regulations on unclaimed.
- 5. These tend to be the most exhausting, labor intensive and emotionally draining of deaths. It is because you and I still believe in the dignity of death we take care of the deceased as our own family. That is one thing that will never change for me.

#### Continued...

- 6. Metropolitan funeral homes and request for deposit/credit card on file BEFORE and removal of body from institution to avoid mass problem of abandoning body.
- 7. No state will allow human remains to be held until payment is made. The family still has the right to change funeral home preference in the midst of planning and the funeral provider must release remains in full or cremated state. Many funeral homes are leaning towards full payment for any or all services so they do not have to incur these issues. This is when the hospital morgue facility will reach maximum capacities.
- And some of the following due to unclaimed individuals...
- 8. There are a huge amount of funeral homes closing due to financial needs, lack of staff, community changes and cost of operation as well as no new ownership.

#### Continued....

- 9. 50% of ownership of funeral homes in the United States is forecast to change in the next five years. Iowa is accurate with 50% of funeral home owners turning 60 in the next five years. This will create consolidation, corporations and alternative means to a community. It will minimize multi-generational firms. I am one-generation. With cost of consolidation, will funeral homes have ability to serve underprivileged communities?
- 10. Two concerns of speaker moving forward- no permanent placement or violation of permanent burial space. Right now, approximately 80K urns are turned in every year being found or unclaimed. The two most often reporters on this are realtors and rental truck companies. For Marshalltown, we have had several reported by police (in dumpster), Greyhound in Omaha, Goodwill store (now four for sale), the auction house, storage shed contacting medical examiner, found in cemetery, etc.

#### Continued....

- 11. The State of Iowa and allowing Medical Examiner approval for disposition if no family will claim.
- Finally, removal of urn from niche for sale of said property to benefit seller. For example- Mr. and Mrs. Jones have been cremated and placed in glass front niches in mausoleum spaces in said cemetery. The children pass and now we are down to grandson as survivor. He has financial challenges or perhaps additions and signs to have ashes removed from niches. He sells such property for fraction of today's price of the cemetery- even with disinterment fees involved, and has the financial means. Now, what happens to Mr. and Mrs. Jones?

#### The future

• As much as I would love to say we resolved everything today and it's going to be a sunny pathway of flowers moving ahead, we all know we are going to have more challenges. With economic needs of families, failure to prepare for events in life that are guaranteed, unraveling of family threads and other reasons that will affect all of us, we need to create the balance of dignified care and minimized impact on authorities and taxpayers. What that balance is may be determined by all of us with planning on the local county level.
